



BEACH PARTY-SPECIFIC RULES
(applicable to ALL members)

Parties may be requested and held by paid active members at Sparta Hills Beach Club (SHBC) under the following conditions:

1. Party requests may be made by **active members** that have their yearly fees paid to date. Reservation requests must be in writing, and **must be received by the TRUSTEES at least two weeks in advance of the requested date** (see page 2). Requests should be forwarded to TRUSTEES and must include the following information:

- a. Name, address, and telephone number of party host.
- b. Date requested for the party.
- c. Starting and ending times of the party.
- d. Number of people attending.
- e. Activities planned (e.g., swimming, volleyball).
- f. Type of gathering (e.g., school, church, children's neighborhood).

A party request is not a guarantee that the party date/time will be available. All date/times will be assigned on a first come first served basis.

2. Beach and/or pavilion will be the usual site for parties.

3. If swimming is planned, **at least 1 lifeguard is required to be contracted from the existing SHBC lifeguards. For groups with over 20 swimmers, an additional lifeguard is required for every 20 swimmers**, e.g., 20 swimmers or less: 1 lifeguard; 21-50 swimmers: 2 lifeguards. The party host **must pay the lifeguard fee upfront** based on party hours and size of party. Arrangements can be made by contacting the TRUSTEES.

4. **All parties shall be limited to 50 persons.**

5. A party fee of \$50, a deposit fee of \$50, and a lifeguard fee in the form of **THREE checks made payable to "SHBC Association" are required for all parties**. The \$50 security deposit will be refunded after TRUSTEES verify that the party site has been left in a clean and satisfactory condition. Host will forfeit the security fee if the beach area (including pavilion and parking areas) are not in a clean and satisfactory condition, with all trash removed.

6. **Weekday parties must end no later than 8pm. Weekend parties must end no later than 9pm.**

7. No glass bottles of any kind are permitted at any event. **NO ALCOHOL**

8. Beaches may not be reserved for money-making or fund-raising activities.

9. **REMOVAL OF TRASH RESTS WITH THE PARTY HOST and must be removed from the beach area** and taken by the host for disposal. THIS IS A REQUIREMENT THAT MUST BE FOLLOWED.

10. All parties must be approved in writing by the SHBC Trustees.

11. **NO FIRES OF ANY TYPE ALLOWED IN FIRE PITS OR ELSEWHERE ON PROPERTY**



Application for Use of Sparta Hills Beach Club Property for Private Party

I have read and agree to abide by all the Beach Party Specific Rules as spelled out on page 1, and the SHBC Rules and Regulations. These rules and regulations govern the use of SHBC property for private party purposes.

I understand that if I fail to comply with these rules, I could lose my future beach party privileges and my deposit. I accept full responsibility for any damages, whether related to personal injuries or property damage, which occur during, arise from, or relate to the private function which I am hosting, which I shall supervise, and for which I have submitted this application. Without limiting the foregoing, I further agree to indemnify and hold harmless (including legal fees and litigation related expenses) the SHBC and its officers, directors, agents, and employees from and against any damages, claims, liabilities and expenses.

I accept full responsibility for any damages that might occur as a result of the beach function for which I am hosting and for which I am applying.
